

Scholarships


Scholarships are often set up for reimbursement to social enterprises providing access to services for charitable recipients.

Compliance

- All grants are reviewed prior to acceptance for compliance. Post funding, systems are set up for grant monitoring. Any updates or requirements are coordinated with the Project or Subsidiary Director for efficiencies
- As long as the Project, Subsidiary is following the guidance outlined in the Operations Manual, the Project or Subsidiary will automatically remain in compliance

Industry specific licensure and processes: Most of these Project or Subsidiary specific licensures and processes are the responsibility of the Project or Subsidiary. In some cases, AnchoRRa can perform some of the tasks associated with some of the back-office support you may need. This is considered on a case-by-case basis. If AnchoRRa is unable to absorb the support needed for the overall fee of 10%, then AnchoRRa will either provide a quote for the additional services or attempt to make a referral to a support expert.

Audit

At this time, we are not performing an annual audit due to the reduced need for an audit. However, as soon as any grantor would need the annual audit as a part of their commitment, AnchoRRa will resume an annual audit frequency.

AnchoRRa includes the audit as a part of the services and no cost is attached or attributed to the Project or Subsidiary.

At this time, we have one physical location located at the Durfee Innovation Society in Detroit, Michigan.


